Notice of liability : Notice of Default: for criminal acts, of conversion by converting the ownership names of record for property upon the Montgomery County Recorder Office records for 2600 Willowburn Ave Dayton Ohio, simulation of legal process, theft, billing for services without contract, refusing tender of payment: Now considered paid by UCC 3-603, false billing, US Mail fraud, *failure of due process*.

Plaintiff :Russell : Joseph: acting as RUSSELL M JOSEPH, MONTGOMERY COUNTY TREASURER vs.

CARL CLARENCE SCHAEFER III. I do not recognize RUSSELL M JOSEPH. Russell Joseph acting as RUSSELL M JOSEPH failed to respond to conditional acceptance for proof of claim-Certified Mail # 7018 3090 0001 7999 6427 having 21 days to answer -Sept. 21, 2019 and other letters, totally ignoring Carl-Clarence :Schaefer III, name holder of Registered business name CARL CLARENCE SCHAEFER III.

The Plaintiff :Russell :Joseph: acting as RUSSELL M JOSEPH is an unregistered fictitious name, not registered with the Ohio Secretary of State, and lacks standing to sue or be sued, and not authorized to conduct business. He fails to show any assumed name certificate.

:Paul :Bradley: acting as PAUL BRADLEY is an unregistered fictitious name, not registered with the Ohio Secretary of State, and lacks standing, and not authorized to conduct any business. He fails to show an assumed name certificate.

:Michael :Krumholtz: acting as JUDGE, MICHAEL W. KRUMHOLTZ is an unregistered fictitious name, not registered with the Ohio Secretary of State, and lacks standing, to hear or maintain an action, or conduct any business in Ohio. He fails to show an assumed name certificate.

:Rob :Streck: acting as ROB STRECK, SHERIFF, is an unregistered fictitious name, not registered with Ohio Secretary of State, and lacks standing, to conduct any business, lacks authority to auction off real estate, property, within Ohio, or State of Ohio. He is doing business in his personal capacity. He has no Sheriff deputies with assumed name certificates, or fictitious name registered, as required to be in Uniform. Every action by the Sheriff's Dept is defective, by officers using fictitious names, which is the same situation with all State of Ohio, State Police, Troopers, City Police, all public officials statewide. They are misapplying statutes, codes, upon Ohioans, and US Nationals, without authority, exceeding their jurisdiction, enforcing District of Columbia codes, UN codes, Unidroit, for the unregistered foreign bar association agents, unregistered Crown agents, unregistered attorneys and/or esquires, directly in violation, opposition to the Supreme Law of the Land, the United States Constitution, by Article 1, Section 8, Clause 17. This violation of denial of rights is, Title 8 USC 1503-Denial of Rights, so I demand remedy under Section 2201 of the Title 28, by department head of public safety, Ohio Governor, Montgomery County Sheriff, forthwith. :Carl Clarence :Schaefer III:, is a US National, an Ohioan, and has never received the required notice from the Dept of State, Dept of Justice, or Federal Courts, giving authorization to sue him, as a Corporation.

CARL CLARENCE SCHAEFER III is a registered business name, which has no contract with :Russell :Joseph acting as RUSSELL M JOSEPH, aka RUSS JOSEPH, no contract with :Paul :Bradley: acting as PAUL BRADLEY, Montgomery County Treasurer, City of Trotwood. Montgomery County Treasurer enforces payment for City of Trotwood Storm water treatment without contract, upon the alleged property tax bills. Russell Joseph failed to provide [a] true bill for property taxes, and added charges from City of Trotwood, rainwater storm drainage, treatment without any contract for services with I, as all current billings are defective, and not true bills, he failed to answer. The alleged bills are written in non-English symbols (see Chicago Styles Manual). All information is divided in separate boxes (see four corners rule), which make every tax bill a fraud, and US Mail fraud. Each separate paperwork within US Mail Fraud is a separate violation, which carries jail time.

I required a signed tax bill from the alleged Treasurer, and a copy showing proof of an assumed name.

He has not followed the Standard Contract Requirements, or good business practices, with so many blatant errors, for a County collecting millions in property tax revenue money.
