I appreciate you bringing your situation to the attention of the Attorney General.



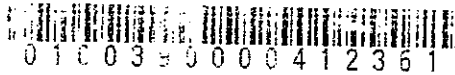


