POWER OF ATTORNEY IN FACT

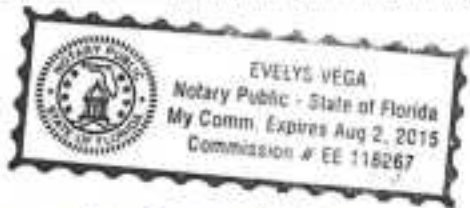
