In the Event Evil Tyrants rules the Plant and the Constitution is suspended or eradicated as we are close to witnessing now, I hereby declare that If I am accused of a crime or falsely declared an enemy, or held in captive against my free will by any human or otherwise, I reserve the right of Trial By Combat to settle dispute and face my accuser or false witness or both, to the Death to prove my innocence under the eyes of God.

The True Hierarchy of Law

Fraud is gaining at the loss of another, using trickery or deception.

Fraud vitiates a Contract. Vitiate: To impair; to make void or voidable; to cause to fail of force or effect. To destroy or annul, either entirely or in part. The legal efficacy and binding force of an

act or instrument; as when it is said that fraud vitiates a contract. (Black's law Dictionary 6th Ed.)

1) Fraud: 37 Am Jur 2d at section 8 states: "Fraud vitiates every transaction and all contracts. Indeed, the principle is often stated, in broad and sweeping language, that fraud destroys the validity of everything into which it enters, and that it vitiates the most solemn Contracts, Documents, and even Judgments." "A void act cannot be legally consistent with a valid one. An unconstitutional law cannot operate to supersede any existing valid law. Indeed, insofar as a statute runs counter to the fundamental law of the land, it is superseded thereby. NO ONE is bound to obey an unconstitutional law, and NO COURTS are bound to enforce it. (Sixteenth American Jurisprudence Second Edition, 1998 version, Section 203 (formerly Section 256)) **A case stops at its first defect and/or at the first point fraud is found. Ignorance of the law is no excuse, especially for those responsible with enforcing the law!**
