Hereby declare that this is my Last Will and
Testament.

1. I revoke, cancel and annul all previous Wills, Codicils and other testamentary writings of statements made or executed by me at any time before.

2. I hereby nominate, constitute and appoint

(i) Martin, Maqiba Malachi, whose domicile of origin is Brooklyn Territory, New York Republic [non-domestic], as the Executors of this my Will and Administrators of my Estate, and in the event the aforesaid party predeceasing or otherwise unable to serve as the Executor,

(ii) I hereby nominate, constitute and appoint Knotts, Geraldine V, whose domicile of origin is Brooklyn Territory, New York Republic [non-domestic] as the Executor of this my Will and Administrator of my Estate, and in the event the aforesaid party predeceasing or otherwise unable to serve as the Executor then

(iii) I hereby nominate, constitute and appoint Hallet, Dennis P, whose domicile of origin is Hesperia Territory, California Republic [non-domestic] as the Executors of this my Will and Administrators of my Estate, and in the event the aforesaid party predeceasing or otherwise unable to serve as the Executor,

(iv) I hereby nominate, constitute and appoint Hudson, Kirk, whose domicile of origin is Goldsboro Territory, North Carolina Republic [non-domestic] as the Executors of this my Will and Administrators of my Estate, and in the event the aforesaid party predeceasing or otherwise unable to serve as the Executor,

If any Executor or Administrator predeceases me, or should said fiduciary according to his or her term of Office or decline to act, then the remaining or surviving Executors according to the order named above, shall be authorized to act alone.

3. I hereby grant to the Executors of my Estate all such powers as are allowed by Law, especially the power of assumption. 4. I hereby direct that it shall not be necessary for my said Executors and Administrators, or any one of them in the event of the predecease of the others, to lodge security for the performance of their duties. 5. I hereby direct that the Executors and Administrators of my Estate proceed with the distribution

of my Estate in the following order of priority (i) Payment of all my debts during my lifetime. (ii) Transfer all right title and interest to Martin, Maqiba Malachi Trust, reserving the right to have the debts of the Estate paid from said Trust, during and after my lifetime. (iii) Transfer all remaining estate to the beneficiary "Hallet, Dennis P Trust" whose domicile is in Hesperia Territory, California Republic [non-domestic] after the debts are paid, and after my lifetime,
