

INTERNATIONAL

TREATY OF PRAKASHKUMAR CHHOTUBHAI BHAKTA

PREAMBLE :

COMES Prakashkumar Chhotubhai Bhakta (hereinafter, "Prakashkumar Chhotubhai Bhakta" aka "Prakashkumar-C:Bhakta " aka "Prakashkumar Bhakta" aka "Bhakta") to notice the global community aka World of his International Treaties:

- 1) Foreign Nation Treaty
- 2) World Peace Treaty
- 3) Multilateral Commerce Treaty
- 4) Declaration of Political Status
- 5) Most Favored Nation Clause
- 6) Ministerial Treaty

FOREIGN NATION TREATY

(Declaration of Political Status)

I, Prakashkumar-C: Bhakta of the Bhakta Estate for the Bhakta of Family, a California, natural-born, free man, on the free soil of his Country the California Republic, am a Sovereign without subjects. I am a Foreign Nation, not a "Person", who rules autonomously, who is not subject to any entity or jurisdiction anywhere.

My authority for this Contract is the age-old, timeless and universal respect for the intrinsic power, property and natural responsibilities of the Sovereign individual. I choose to comply with mutual respect, which serves to bring harmony to society". All national, international and state "constitutions, laws, statutes, ordinances, regulations, rules, codes and public policy, " in all nations and states are private copyright material and consequently this material does not have any authority over me, my personal affairs or my property. I have complete sovereign immunity and therefore my power to contract is unlimited.

I am a living, breathing man, an American man of the American Republic, beneficiary to the original jurisdiction.

I am not a "United States Citizen," subject, vessel or "person" as defined in Title 26, United States Code ("USC"), Section 7701, or elsewhere, or any other ens legis artificial person, individual, entity, fiction of law, procedural phantom or juristic personality, notwithstanding the reproduction of any such fictions in any media, computer, record or instrument, written or electronic.

I am foreign to the "United States" and retain official authority within my chosen jurisdiction. As beneficiary to the original jurisdiction, I am not subject to nor do I volunteer to submit to or contract with any ens legis artificial or corporate jurisdiction to which a "United States" "person" may be subject.

I reserve all rights, remedies and defenses granted to me by my Creator and memorialized by my correct public capacity as beneficiary to the original jurisdiction.

I waive no rights, remedies or defenses, nor yield any imprescriptible rights, including, without limitation, the right to movement and or travel without restriction, permission or license in any conveyance of my choosing on any public roadway in America or throughout the World, and the right to bear arms for the protection of my family, friends and neighbors without restriction, unless such waiver is specifically done so in writing.

I reserve the nature and character of my exact and proper designation as: Prakashkumar-Chhotubhai: Bhakta

or, in the alternative, Prakashkumar-Chhotubhai of the family Bhakta, which shall be spelled, written, formatted, printed, engraved and or inscribed now and in perpetuity in all media exactly and precisely as just above-written with a first and second given name separated from, and joined to, a family name by a mark of punctuation or the words "of the family", with the first letter of each given and family name being capitalized and all other letters being written in lower case fully in accord with the Rules of English Grammar.

Trade Mark notice. My name, by common law, is trademarked, and all trade names and derivatives thereof, whether registered or not, are trademarked as my property, with all rights reserved. The use thereof without my express written permission creates a voluntary and informed consensual contract obligating unauthorized users to the payment of a trade mark infringement fee as follows:

A sum certain of ten thousand (\$10,000.00) dollars lawful specie, gold or silver, American mint or certified bullion, lawful coin money at current spot market price, pursuant to the Constitution for the United States of America, 1787 anno Domini, amended anno Domini 1791, Article 1, Section 10, Clause 1, shall apply to each unauthorized use of my name and each attempt or event of conversion, alteration, distortion and or misnomer, whether by improper spelling, abbreviation, capitalization, initialing, reversal of parts or conversion to a fiction of law or other juristic personality or artificial being.

The legal doctrine of idem sonans is inapposite to me, whether oral or written; all such improper usages and misnomers comprising infringement on the above-noticed copyright.

I do hereby accept the original jurisdiction of, to wit:

- a) The Constitution for the United States of America, 1787;
- b) Articles of Amendment, 1791;
- c) National Bill of Rights, 1776;

- d) Constitution of California, 1850;
- e) Bill of Rights for California, 1850.

The de jure private people who, by their inherent character in rerum natura, are foreign to and wholly without the corporate ens legis "United States," are not subject to the actions, acts, and whim of ens legis Congress of the corporate "UNITED STATES."

My labor is measured and valued quantum meruit exclusively in gold and silver. As the value of such labor is tangible, it cannot be measured by any instrument which serves as evidence of debt, notwithstanding that the operational currency of the corporate "United States" consists exclusively of instruments noted thereon to be evidence of liability.

I am not now and have never been a "United States Citizen," under the Fourteenth Amendment of the ens legis Constitution for the corporate "United States," notwithstanding any failures to properly pass said amendment into law.

I, in my capacity as descendant, by blood, of the Original Bailor/Grantor/Settlor, and His endowment to warrant same, by my Almighty Creator, pursuant to the terms, conditions, stipulations, exceptions and reservations contained within the Original Grant, do enjoy and possess unalienable rights, now and forever.

I make all these declarations, first, to my heavenly Father, my Creator, then, to the heavens, all the World, universal entities, Mother Earth, all inter and outer dimensions, spaces, spirits and principalities and celestial beings; to the United States of America, all corporate names derived thereof; to the Queen of England, British Parliament; to the Roman Vatican Church and acting Pope; to all future Popes, archbishops, bishops; to all abbots, earls, barons, Justices, forresters, sheriffs, stewards, servants; to the Knights of Templar, the International Monetary Fund Group families; to the United Nations, all World Government officials; to all corporate entities; to the World Trade/Health Organizations; Trilateral Commission; the Hague World Court; the U.N. Economic Development Council, Security Council; International Chamber of Commerce; European Union; all Asian and African Nations; to all Countries, States, cities, Municipalities, Counties, both corporate and non-corporate, to all my fellow Brothers and Sisters; to all Living Souls found throughout this Earth, and beyond, this:

WORLD PEACE TREATY

I AM Bhakta, a living, breathing Soul, and sentient Man. The Son of my heavenly Father, our Creator and Supreme Being, I am the heir to my inheritance, bequeathed before the adoption of any Constitutions, by the paramount authority granted in me by our unalienable rights, coming in Peace, with Love, Harmony and Truth, to invoke the great I AM. I and my Creator are One.

"I AM the State," the State of Bhakta, of the Bhakta Family. I do declare I am self-governed, in a form suitable for international public order, to insure my safety, liberty and the pursuit of happiness, for the benefit of my posterity. This pledge is founded upon my Supreme Creator's Pillars of Universal Law and Truth.

I declare this treaty with my guarantee of peace, in whole agreement with the Magna Carta and the American Declaration of Independence. May we keep and restore peace on a universal, planetary scale, under the law of nations, as my birthright. This is my covenant, my international private and public peace treaty.

MULTILATERAL COMMERCE TREATY

I declare a multilateral treaty concerning trade and or other mercantile activities for long term commercial relations, free to trade, or engage in other commercial transactions. Guarantee mutual and reciprocal support to bind all parties named above; to no injustice and to always act in good faith. Agree not to engage in any reactionary manner towards others, whether jointly, with others, or individually, nor to interfere with their affairs.

I declare reinsurance upon this treaty to cover all lines of business of the reinsured, such as all property stated in my Master Security Agreement compact (No. SA-72111-PCB), with my unlimited amount of credit in United States dollars as the Creditor which is obligated by the corporate government of the "United States," and any derivatives thereof. This is my covenant, my international private and public multilateral commerce treaty.

MOST FAVORED NATION CLAUSE

I declare my unalienable rights to enjoy the status conferred by the most favored nation clause of each respective Sovereign, among all the powers of this Earth, respective to all their heirs, territories, citizens, laws, property, property of private individuals, goods and effects, grant, subjects, commerce and trade. In exchange, I agree to afford the other all the rights, prerogatives, immunities and privileges which are or may there after be granted to their most favored nation. This is my covenant, my most favored nation clause.

MINISTERIAL TREATY

I declare my ministerial treaty, my diplomatic duty under the international laws of public and private order.

Mandatum Manifestum Special Proclamation Heirship In the Law of My Creator

Oyez, Dominus Rex Prakashkumar Chhotubhai Bhakta. That is said, Novim Judicium Non Dat Novum Jus, Sed Declarat Antiquum; Quia Judicium Est Juris Dictam Et Per Judicium Jus Est Noviter Revelatum Quod Diu Fuit Velatum.

I AM Bhakta, in faith, Heir of a Line of Heritable Rights. Being of sound mind, I AM competent to state the truth, of the matters at hand, to be True:

Sensus Verborum Est Anima Legis that I Declare and Proclaim this Creed with the Decalogue to unveil the Mystery of these God-inspired words to be true, that I, Prakashkumar Chhotubhai Bhakta, Vicar to my Creator, to be Dominus Rex, a living, breathing, soul, a Son of IAM.

Genesis 1:26 - And IAM said, Let us make man in our Image, after our Likeness, and let them have dominion over the fish of the sea, and over the fowl of the air, and over the cattle, and over all the creeping things that creepeth upon the Earth. So IAM created man in his own Image, in the Image of IAM created he him, male and female created he them. And IAM blessed them and IAM said, unto them, Be fruitful and multiply and replenish the Earth and subdue it, and have dominion over the fish of the sea and over the fowl of the air, and over every living thing that moveth upon the Earth. And IAM said, Behold, I have given you every herb-bearing seed which is upon the face of all the Earth, and every tree, in which is the fruit of a tree yielding seed, which is upon you. It shall be for meat. And to every beast of the Earth, and to every fowl of the air, and to every green herb for meat. And it was so. And IAM saw everything he had made and, behold, it was very good.

Genesis 3:5 - For IAM doth know that in the day ye eat thereof, then your eyes shall be opened, and ye shall be as gods, knowing good and evil.

Psalms 82:5 - They know not, neither will they understand. They walk in darkness. All the foundations of the Earth are out of course. Have said, ye are gods; and all of you are children of the most High.

John 10:34 - The Anointed One answered them, Is it not written in your Law, I said, Ye are gods? If he called them gods, unto whom the word of IAM came, and the scripture cannot be broken.

Psalms 89:3 - I have made a covenant with my chosen; I have sworn unto David, my servant, thy seed I will establish forever, and build up thy throne to all generations.

Psalms 89:19 - Then thou spakest in vision to the Holy One, and saidst, I have laid help upon One that is mighty; I have exalted One chosen out of the people.

Psalms 89:34 - My covenant I will not break, nor alter the thing that is gone out of my Lips. Once have I sworn by my holiness that I will not lie unto David. His seed shall endure forever, and his throne, as the Sun before me. It shall be established forever, as the moon, and as a faithful witness in heaven.

Psalms 94:14 - For IAM will cast off his people, neither will he forsake his inheritance, but judgment shall return unto

righteousness. And all in the heart shall follow it.

Psalm 105:7 - He is our I AM. His judgments are in all the Earth. He hath remembered his covenant forever, the word which he commanded to a thousand generations, which covenant he made with Abraham, and his oath unto Isaac; and confirmed the same unto Jacob for a law, and to Israel for an everlasting covenant, saying unto thee, will I give the land of Canaan, the lot of your inheritance.

Revelation 21:16 - I have sent my angel to testify unto you these things in the churches. I AM the root and the offspring of David, and the bright morning star.

May it be to the World what I believe it will be to some parts sooner, to others, later, but finally to all. I have burst these chains of ignorance and assumed the blessings and security of self-government. May eyes are opened to the rights of my inheritance. By the lights of science the same has laid open to my constitution the palpable truth, by the grace of the almighty Creator. I have returned this day, and undiminished devotions, of these unalienable rights and an undiminished devotion to them, with love, peace and harmony.

This Covenant that I, Prakashkumar Chhotubhai Bhakta, do declare and proclaim, to keep with my Creator, I AM, to be a sovereign king over my temple, a foreign nation who rules autonomously, without subjects. Worthiest of blood, I claim to be Bhakta, the instrument founded on the account. By virtue of the authority of my Creator, I AM. La Ley Favour L'Enheritance D'un Home. A Coelo Usque Ad Centrum Cujus Est Solum Ejus Est Usque Ad C Celum. Ab Intio Mundi, A Terme Prakashkumar Chhotubhai Bhakta Sa Vie. A Luy Et A Ses Heirs A Touts Jours.

This, by conviction of mind, a conviction of truth, since the beginning. Anno Orbis Conditio. With the knowledge of belief to be and stand as truth. So it is written, with thy hand, so shall it be done. In Nomine Dei, Amen.

NOTICE is hereby given that Prakashkumar Chhotubhai Bhakta, by special declaration and special proclamation to the Earth and the Heavens, that after five (5) days of receipt and recording, failure to rebut, deny or otherwise prove any allegation will be construed to be failure to rebut, deny or otherwise prove all allegations. It is affirmed. In Nomine Dei, Amen.

Furthermore, this international treaty may be revised and or amended in the future at the sole discretion of its maker, Prakashkumar Chhotubhai Bhakta. It is an abbreviated version of a larger document signed on October 31st, 2012. Also, notice to principal is notice to agent and notice to agent is notice to principal. As such, by this public notice and declarations, the World is now informed, notwithstanding the use of a notary public made herein or elsewhere is, by necessity, where deemed pertinent or applicable, is made under protest and without creating or implying the existence of any contract between myself and any

other parties or legal entities or their agents thereof, whether public or private.
