#### **Plain Statement of Facts:**

On 3/3/2015 I, tommy-wilson:beaumont family III of (herein "affiant") requested LYNN GRIMM (herein "Notary Acceptor") to perform an official ministerial function as notary public acting as an independent, neutral, disinterested third-party, second witness and keeper of the record on a tender affiant made to:

Affiant further requested the Notary Acceptor if necessary, to perform a protest pursuant to U.C.C. § 3-505 and issue a Certificate of Non-Response in the event Respondent failed to perform as requested in the noted tender. The intent of this affidavit is to document Respondent's non-performance and non-response and the resulting **Default**, as well as their knowing and voluntary **Consent to Judgment** in this matter.
- 12. Notice of the **Judgment** will be recorded on a UCC-1 Financing Statement with the Secretary of State in South Carolina state.
- 13. This mailing to Respondent now marks the 3<sup>rd</sup> correspondence sent to Respondent requesting them to provide a lawful reason why they have failed to perform as requested on the above noted tender by setting off, settling and closing the account in question.
- 14. Affiant herein certifies that Respondent has dishonored the above noted tender for setoff, of the above identified account.
