Whereas it is my understanding the united States for America is predicated upon unalienable rights as secured by God our Creator,

Whereas it is my understanding our nation predates any form of government, it is Sovereignty itself as extended to those who claim the land,

Whereas it is my understanding a statute and ordinance and the agencies created from these are predicated upon inferior laws under the hierarchy of Common Law,

Whereas it is my understanding a statute is legislated rule of

society which has been given the force of law via color of law, his renders it null and void ab initio,

Whereas it is the only form of de jure government recognized in America is a Representative Republic,

Whereas it is my understanding a representative government requires mutual consent,

Whereas it is my understanding in the absence of mutual consent, neither government nor representation can exist,

Whereas it is my understanding that all Acts are statutes restricted in scope by and applicability by the Bill of Rights, organic Constitution for the several States, the Preamble and the Declaration of Independence,

Whereas it is my understanding that the government is the servant of the de jure free population,

Whereas it is my understanding said scope is limited to those federal employees and those who reside within the 10 square miles of Washington DC,

Whereas it is my understanding that the living Souls who comprise We the People may revoke their consent to be governed at any time,

Whereas it is my understanding that i, Tracy Brown Egan, am NOT the idem sonans TRACY BROWN EGAN,

Whereas I have given notice to such statutory agencies and their employees that I am a living breathing Soul under God with unalienable rights,

Whereas I have given Notice to such statutory agencies I do not consent to their interference in my life, nor do we have a valid contract,

Whereas it is my understanding should they erroneously consider anything I have any ever signed to be consent, I now rescind and revoke my signature for good cause, thereupon releasing me from any adhesion contract,

Whereas it is my understanding that acting peacefully within the community standards does not breach the peace,

Whereas it is my understanding a peace officer should not be

called except for a breach in the peace, nor does a peace officer have any official capacity when acting under Color of Law for any and all corporations,

Whereas it is my understanding that a peace officer is required to distinguish between enforcement of corporate codes and statutes versus Common Law,

Whereas it is my understanding that a summons is merely an invitation to contract, creates no obligation, and I may decline without dishonor,

Whereas it is my understanding I have a God given right to decline interaction with an officer who is acting within his corporate jurisdiction,

Whereas it is my understanding as a Sui Juris, Common Law Soul, I am free to concern my self and take full responsibility for my own medical care, health well-being and conditions, as well as those for my minor daughter,

Whereas it is my understanding agencies created under statutory authority instead of lawfully have no jurisdiction over

me and I may decline to interact with them at any and all times,

Whereas it is my understanding that a contract entered into under duress, intimidation and coercion is not a valid contract and is void ab initio,

Whereas it is my understanding that I am Sui Juris, Sovereign, of sound mind and mentally competent, and a fully independent and responsible Soul,

Whereas it is my understanding that my daughter, a flesh and blood Soul, Campbell Egan, is fully under my authority and no agency has any right nor jurisdiction to interfere with my God given parental rights,

Therefore be it now known to any and all concerned and affected parted that I, Tracy Egan, do hereby state my intent to live peaceably and lawfully on the land within the maxims of Common Law which has existed since time immemorial. I am free to lawfully exist unencumbered by all statutory obligations and restrictions and do make a reservation, without prejudice, of all Common Law rights as secured by the Creator.

Furthermore, I claim my Common Law right to refuse consent to

interact with these statutory agencies; I claim this right on behalf of my minor child.

Further, I am claim the right to be free of corporations acting in my purported best interest when only I can know what is in my best interests, as well as my daughter's best interests.

Whereas I am a competent, loving parent, I claim the right to not have my actions misconstrued or judged by others.

I claim the right to not have any interference from any agency used against me to restrict my God given rights.

I claim the courts of the united states are de facto and in fact in the profitable business of conducting, witnessing and facilitating the transactions of security interests.

I claim the agencies created under statute to be operating unconstitutionally within the de jure nation.

I claim the right to be non-domestic.

I claim the agencies such as HHS and CPS, but not limited to HHS and CPS, which operate unconstitutionally to be in the

business of using threats, intimidation and coercion to steal rights away from We the People and living Souls.

I claim unconstitutional agencies such as CPS to be in the business of unlawfully intervening in the lives of Souls to lay claim to Trusts created by the corporations and to use the surety for corporate gain.

I claim the right to come and go freely from where I sometimes temporarily dwell at 1520 York Avenue, Manhattan, without fear of approach from agency employees.

I claim the right to be contacted by said agencies solely through ~~XXXX~~ Paul Duhg.

I claim the right as a living Soul to be free from all corporate harassment, detainment, kidnapping, harm, interrogation and trespass.

I claim the right to raise my flesh and Soul blood child as I see fit, free from any and all intrusions.

I claim the right to have my rebuttal presumption of Parens Patriae recognized and adhered to.

I claim the right to be free from all UCC/Maritime and Admiralty laws and jurisdictions, for both myself and my daughter.

I claim the right to have my daughter secured as my private inviolable property, as recorded in my Security Agreement.

I claim the right not to be subverted nor undermined as the de jure full custody parent, by Steven Schulman, who has refused to see our child since November 2011 of his own accord.

I claim the right to enforce the No Contact Order as set forth and agreed to with Steven Gary Schulman; I claim the right to be free from all equity administrators, including Laura Drager who has been placed in irrevocable Dishonor and has no jurisdiction (nor ever had authentic jurisdiction).

I claim the right to enforce the conditions heretofore agreed upon and verified in a contract, that Steven Gary Schulman meet with a therapist who shall be in charge of reunification with our flesh and blood daughter.

I claim the right to protect my minor child from her adult psychologically impaired half-siblings, who are medicated and
