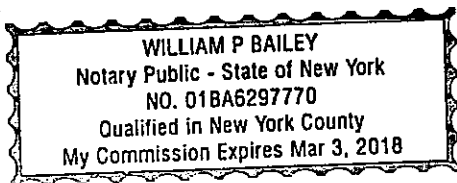

This NOTICE is a just and modest self-defense and remedy for trespass against me and my family and well below the precedent set by James C. Trezevant in JAMES C. TREZEVANT vs. CITY of TAMPA wherein damages were at \$25,000.00 for 23 minutes of unlawful detainment. That remedy calculates to more than \$1.5 Million per day.

Fee Schedule:

A.) 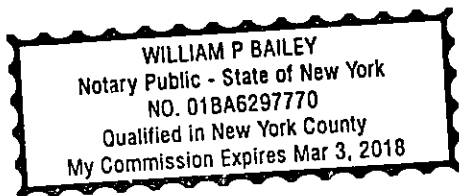
